Search and seizure operation under section 132(1) of the Income Tax Act, 1961 was conducted in the case of SRS Group of cases on 06.06.2018. The search and survey action which was conducted on the business as well as the residential premises of this group had resulted in unearthing of undisclosed cash, jewellery and other incriminating evidence relating to concealment of income. During the course of search and survey proceedings at the various premises of SRS group and its associated persons/middle man various papers were found and seized which shows unaccounted investment in property.

2. For the assessee company SRS Ltd. several properties have been identified these are listed below:-




