HITECH PROJECTS LIMITED DREAM HOUSE approached the undersigned in March, 2016 and stated that their Company and they themselves are in the business of Real Estate and have got free hold plots in the area near Good Year Factory, Mathura Road, Blb. Faridabad. They assured the undersigned and my wife Smt. Swaran Kanta Gera that the said plots are free hold and they are the legal owners of the same and they possess all the permits that are required for developing a Colony/Industrial Estate. That on the inducements made by the aforesaid accused persons, the complainant who is the owner of News Paper M/s. Tej Tarar got trapped and made a full and final payment as per settlement of Rs. 27,27,500/- for allotment of Plot No. 452 for open office of TEZ TARRAR NEWS in the project namely "SRS EMERALD COURT" DREAM HOUSE. Similarly my wife Smt. Swaran Kanta Gera also got trapped on account of their false assurances and also made a payment of Rs. 27,27,500/- for allotment of Plot No. 451 in the same project. The relevant papers in this regard are enclosed herewith. That the He applicant is a peace loving law abiding, RTI / PIL / SLP / known Social Worker/Human Rights Activist / Spirited person and Senior citizen of India. (Age 68 year above) Who is a whistleblower, Chief Editor/Owner of Hindi Newspaper "TEJ TARRAR News', Ex Advisor of Municipal Corporation Faridabad to check all chances of corruption and leakages and reporter on JAIN TV, NEWS DELHI General Secretary of CRIME FREE OF INDIA Bureau, National Crime and in his own humble way, resident of Faridabad, Haryana and has been undertaking many social activities for the welfare of the general public, and is dedicated to weed out the menace of corruption from the Society. Applicant as filed various Public Interest Litigations against the policies of Govt. Of Haryana which are directly benefiting the builders, white collars land mafia and covering up the misdeeds of corrupt officers of the Government and Municipal Corporation Faridabad and HUDA department. Complaint, in order to curb and control menace of encroachment at public lands Reserve for public benefits green belts, parks, footpaths in the name of temples, schools, mosques, Gurudwaras and churches and also to prevent misuse of land from residential to commercial / industrial, and Hundreds crores huge Frauds. On account of his continued fight against the system, by making the people aware by organizing workshops, sensitization and legal awareness camps and suggesting / proposing necessary through public interest litigation,. The disgruntled elements of the Society at the instigation of. He has filed various Public Interest Litigations against the Govt. I continued to make requests to them through SMS messages and also Whatsapp messages from time to time. However, they continued to avoid the complainant and his wife on one pretext or the other. On one occasion Sh. Anil Jindal accused save a SMS message to the undersigned and admitted his liability. That now the complainant-Tez Tarrar News has come to know that the aforesaid accused persons have played fraud with the undersigned and his wife Smt. Swaran Kanta Gera as they did not had any rights to sell the said plots and also various permissions from Department of Town and Country Planning, Haryana to develop a colony/industrial sector. They have duped us of our hard earned money
